#### 2311 Clerk's Report

Community Payback Scheme – Suggestions from residents and members included litter picking, gardening, painting and general maintenance. The Clerk would send a request to the Probation Service.

Horse riders – The Clerk had contacted ERC for advice in relation to reports of horse riders using the cut through to St. Anne's Walk and St. Helen's Drive. ERC had advised that whilst not encouraged in any way, horse riding on a footpath was not illegal and it was noted that there was currently no local bylaw in operation in the area to prohibit riders. The Clerk would re contact ERC to enquire whether signage encouraging riders to dismount could be an option.

Items discarded at Beck Lane – A metal barrier and garden rubbish deposited on the highway verge had been removed by ERC.

Road junction at The Green, Church Street and Creyke Lane – The Clerk had contacted ERC to request the re painting of faded lines at the junction to alert drivers travelling along Church Street to the fact that the road at this point becomes two-way. The Clerk would also report the double white line in the

centre of the road opposite the Green Dragon, which also required re painting for clarity.

Queen's Jubilee Tree – It had not been possible to engage the chosen contractor to supply and plant a tree for the Queen's Jubilee. The Clerk was authorised to contact an alternative supplier and would report back.
