2476 Clerk's report

Update on minute 2472 (i) & (ii) - A service request had been made for the reassessment of road marking and traffic signage within the Parish, including repositioning of the speed sign at the junction of Kidd Lane and Cowgate presently obscured.

Clarification had been obtained by the Clerk that the Police have the appropriate powers to issue penalties for vehicles parked dangerously, including vehicles left in restricted areas resulting in obstruction of the highway.

St. Helen's Clock - The annual service of the War Memorial Clock had been completed by the Cumbria Clock Company and no issues of concern identified.

Local elections 4 May 2023 - Election Notices would be published by ERC on 17 March 2023. Nomination forms are to be returned to County Hall not later than 4pm on 4 April 2023.

Winter grit bins - Maintenance visits had been completed by ERC at St. Helen's Drive and Creyke Lane.

Silt trap maintenance – The next maintenance visit would take place on Wednesday 1 March.

2477 Correspondence List - The correspondence list was noted.

The Clerk would respond to the Street Trading and Collections Licensing Policy Review highlighting concerns regarding the single use of plastic bags for charity collections. Members wished to see the introduction of a requirement for a bio degradable alternative to the plastic bags currently in use.

2478 Report from the Memorial Hall Trustees

Cllr Thane reported that hire fees would be increased from 1 April. A number of events had been planned for 2023, to include a Coronation Event on 6 May, events had been well attended to date. Quotes were presently being obtained for roof repairs.

2479 Welton, Melton and Wauldby News

The February edition had been published. A number of new advertisers had been added and some new distributors had come forward.

2480 Grant Application Welton Memorial Hall

Resolved – that (i) a grant of $\pounds 24,350.00$ be awarded to the Trustees of Welton Memorial Hall to be used towards the costs of a new storage facility, (ii) payment of $\pounds 24,350.00$ be authorised and (iii) copies of all invoices in relation to the works be sent to the Clerk for Parish Council accounting records. Proposed by Cllr Taylor and seconded by Cllr Paterson

Melton Underpass CCTV – update Cllr Thane informed members that a grant of £25,000 had been offered to the Parish Council towards the costs of CCTV for Melton underpass. Members were reminded that the Parish Council had previously agreed to make of one-off contribution of £3,500 (minute 2405 refers) at the request of the Ward Cllr, to be matched by Swanland and North Ferriby Parish Councils, towards the purchase of CCTV equipment only, to be installed, monitored and maintained in its entirety by ERC. Members concluded that the draft legal agreement to be signed prior to release of the grant, had wide ranging implications for the Parish Council in the longer term and the role of Project Manager allocated to the Clerk by ERC was outside of the Clerk's job profile.

Resolved – that the draft legal agreement and grant be declined by the Parish Council.

2482 Maintenance of the silt trap 2023-24

Resolved – that the contract for maintenance of the silt trap during 2023-24 be awarded to Clearway Environmental Services Ltd on the basis of the quote provided

Resolved – that Cllr Thane be nominated as the Parish Council representative on the King's Coronation Working Group. Proposed by Cllr Taylor and seconded by Cllr Peck

2485 Community Governance Review

Resolved – that the Clerk completes and submits the review on behalf of the Parish Council. Members indicated that they did not consider boundary changes or changes to the number of places on the Parish Council to be necessary. Proposed by Cllr Thane and seconded by Cllr Gill

2486 Watercourse update and rewilding (Cllr Paterson)

Cllr Paterson reported that he had taken advice on the management of the water course. Members were informed that in relation to the impact of sediment, the silt trap captured the bed load only, defined as anything on the bed of the watercourse. Advice was that the most effective way to trap sediment was to let the system do its own thing, in other words let the water course re-naturalise, with sediment removed from the embankment during winter supplemented by flood deposit removal as necessary. Members were informed that vegetation acts in slowing water and would be beneficial to support wildlife in the future.

It was noted that enquiries had also been made as to the potential availability of land to purchase and plant trees. Giving seeds to local schools for pupils to cultivate was presented as another option to support re-wilding.
