1664. East Riding of Yorkshire Councillor's report

Cllr Abraham reported the following:

Following the extensive option appraisal and to ensure the authority receives the best value out of the investment for the school, a decision has been made and supported by the full governing body to move St Anne's School and Sixth Form to the former lower school site in Hessle. The move to Hessle will not happen until the summer of 2021 on completion of the build and the authority will be exploring options for the future of the site in Welton for the development but this will be subject to the formal planning process. Councillor Banks asked what would happen to the issues over congestion and litter in the interim period prior to the new school being built.

The leaflet regarding Transwaste had been delivered the businesses and Churches have put in an objection related to 21 generators near consecrated ground. Enforcement issues were discussed related to planning and Councillor Abraham read out a resident's objection related to the Transwaste development which raised concerns over health and wellbeing of residents affected.
