Minutes of Meeting held 18th June 2019 at 7:00pm

Present were Councillors Thane (chair), Rockett, Banks, Gill, Peck, Walker, Abraham, Boyle Also in attendance was the Clerk

1816. Public Forum

Twelve residents were present wishing to speak in regard to a planning application, item 1825 a iii.

The following comments were made by residents:

The proposed building will block the view from houses due to three storey concrete block in relation to house next to college blocking views on all sides.

Not enough services/ infrastructure to support the development

South Hunsley School already creates chaotic traffic congestion so development would only worsen this. Increasing number of students using cars and not enough parking exacerbates this. School do not do enough to ensure road safety but acknowledged that they are not part of the plan.

No access points are specified in the plan and road safety has not been addressed

The artist impression does not make it clear whether trees will be preserved and residents wondered if the trees would have preservation orders.

Potential impact on environment in relation to water, waste and flooding has not been addressed in the proposal. The flood barrier has been removed at Melton Bottom which Yorkshire Water need to be aware of. In addition impact on wildlife e.g. newts and badger has not been mentioned.

Residents mentioned the existing problems in relation to traffic including speed restrictions not be adhered to, i.e. some cars travel at 60/70 MPH in a 20/30MPH zone; parking on yellow lines (not enforced by ERYC) and obstruction of bus stop due to parking.

Residents agreed that the proposed development would change the character of the area and that they wanted their village to remain rural and that they were unanimously against the planning application. The PC advised residents to put forward their own comments on the public access planning portal. The general consensus was that the proposal development is inappropriate development in the countryside.

The status of the land is an unallocated site and a previous planning proposal was dismissed. Residents questioned whether the existing development by manor properties on the site should be subject to planning as the mound of soil is so high. Councillors urged the residents to comment on the planning portal and that both Ward Councillors contact ERYC in terms of the enforcement officer.

Both Cllr Walker and Cllr Abraham both attended the Brough South Liaison meeting. Cllr Thane to be invited to future Brough South Liaison meetings. Councillor Meredith from Dale Ward is the new chair of the Brough South Liaison group. Phase 3 of the Brough South development is due at Committee 20th June 2019.

Cllr Abraham reported the following:

There is a campaign to stop anymore building of houses until the roundabout is finished sighting the Beverley example where infrastructure was built before housing. Developers are raising the height of the land on Common Lane and first lot of houses will be available August 2019. The supermarket has been confirmed as Aldi. Resident complaints have been received regarding Gibson Lane and noise complaints from Heron Refrigeration Lorries which are kept overnight. Cllr Banks commented on the fact that the Hessle rebuild of St Anne's has not gone to planning yet and the numbers of children having risen from 50 to 160. Cllr Abraham commented on the sad fact that more children have special educational needs and also the success of the school.
